RELEASE AND INDEMNIFICATION AGREEMENT

The undersigned (on my own behalf and on behalf of my heirs, personal representatives, successors, and assigns), for and in consideration of the opportunity to participate in a "Ride," and/or "Event"(hereinafter EVENT(S)), sponsored by Women in the Wind, and/or Riverside, California Chapter and their respective officers, directors, employees, agents and members (hereinafter RELEASED PARTIES) releases and holds harmless the RELEASED PARTIES from any and all claims and demands, rights and causes of action of any kind whatsoever which I now have or later may have against the RELEASED PARTIES in any way resulting from, arising out of, or in connection with my participation in any said EVENT(S).

This release extends to any and all claims I have, or later may have against the RELEASED PARTIES whether or not such claims result from negligence (except willful neglect) on the part of any or all of the RELEASED PARTIES with respect to the EVENT(S) or with respect to the conditions, qualifications, instructions, rules or procedures under which the EVENT(S) are conducted or from any other cause. I UNDERSTAND THAT THIS MEANS THAT I AGREE NOT TO SUE ANY OR ALL OF THE RELEASED PARTIES FOR ANY INJURY RESULTING TO MYSELF OR MY PROPERTY ARISING FROM, OR IN CONNECTION WITH SAID EVENTS(S).

I am experienced in and familiar with the operation of motorcycles and fully understand the risks and dangers inherent in motorcycling. I also have a valid motorcycle license or endorsement. If I carry a permit, I am aware of the restrictions and any violation is solely my responsibility. I am voluntarily participating in the EVENT(S) and I expressly agree to assume the entire risk of any accidents or personal injury, including death, which I might sustain to my person and property as a result of my participation in the EVENT(S), whether or not such risk results from negligence (except willful neglect) on the part of any or all of the RELEASED PARTIES.

I agree that I will not ingest any alcoholic beverage or any substance or drug (legal or otherwise) that may adversely affect judgment or physical coordination before or while participating in any EVENT(S) or any other activity in which alcohol or such substances could adversely affect the ability to operate or control a motor vehicle.

WAIVER OF RIGHTS UNDER STATE STATUTES

I further agree to waive all benefits flowing from any state statute which would negate or limit the scope of this Release and Indemnification Agreement.

By signing this, I certify that I have read this Release and Indemnification Agreement and am not relying on any statements or representations made by RELEASED PARTIES.
